KAK Holds Special Briefing to Begin Planning for 2011 Corruption Survey

Dili. KAK Commissioner Soares and 12 key staff held a Special Briefing on Saturday, March 12, to begin planning the 2011 Corruption Survey.

“We intend to present the results of the survey on International Anticorruption Day, December 9,” said Commissioner Soares.

The Special Briefing covered survey examples from other countries. Examples included - Household Surveys and surveys on Corruption in Service Delivery. The briefing also covered a more intellectual Institutional Vulnerabilities Analysis that is typically conducted by outside experts.

The Special Briefing was prepared for KAK by USAID consultants, who will also be providing financial support to implement the survey.

“We will carry out this survey for at least three consecutive years,” said Commissioner Soares. “We will closely examine the options and select a choice that will help focus our anticorruption strategies.”
